## Mazini Energy & Power Inc. and PanAm Energy Development Corp. Proposed Oil and Gas Development Joint Venture

PanAm and Mazini signed mutual Non-disclosure Agreements (NDAs) at PanAm's offices on January 23<sup>rd</sup>, 2024. The signing of these agreements along with a Memorandum of Understanding (MOU) now being finalized contemplate Mazini making arrangements for PanAm to enter into Joint Venture development operations with First Nations on and off Reservations within Areas 1–3 as shown in the following map.



# Brian Mountain & Chief Roy Jones Our Resources Are The Key To Our Sovereignty

Brian Mountain of Mazini Energy and Power Inc. and Hans Schmidt of PanAm Energy Development Corporation recently reached agreement in principle to work together to formulate a Joint Venture Concept to bring together a "Coalition" of First Nations to



study Oil and Gas deposits, procure the necessary funding to develop and tie them in for production, near and on Indigenous Sovereign Reserve Lands.

In addition, PanAm's Environmental, Social Governance concepts (ESG) are in alignment (see their Pledge attached as a short Pptx) with Mazini's objectives and Indigenous Peoples' deep-rooted beliefs in general. This would make for an orderly and realistic transition from a predominantly fossil-fueled world to a more environmentally friendly balanced energy space, feasible.

The Coalition, as envisaged, will allow First Nations the opening to make-up for lost opportunities after years of restrictive policies imposed on us and, as well, will permit industry partners regain sunk costs, ie., "the Risk Monies" invested to hunt for and delineate needed reserves as determined in years past when the fear of running out of oil [see Club of Rome – Limits to Growth] or geopolitical concerns from time to time were the main drivers of exploration for oil and gas.
